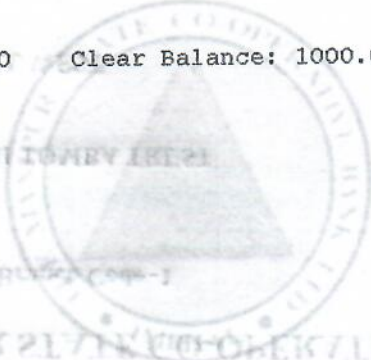

He gave birth to five sons (Budhi/Tekpan/Brojen/Phulen/Leibakmacha). He was a very good chess player and was a philanthropist in his capacity. He was expired on 25th Dec, 1990 at the age of 61.

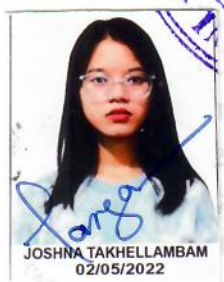

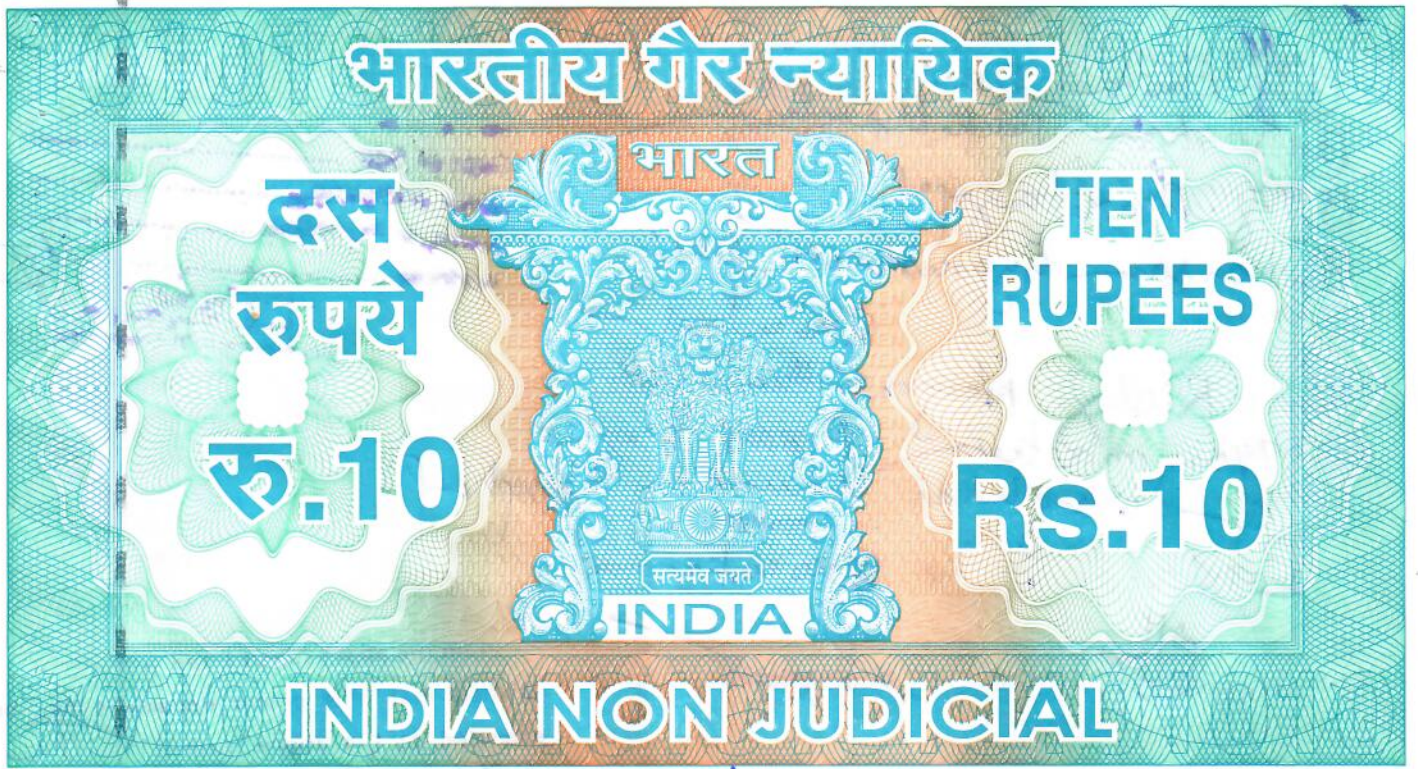

**T.Landhoni Devi** was born at Khabi to Meitram Amuba & Chaobihal. Right from her childhood she was a fighter and had to struggle for survival. She was the third child of her parent. She got eloped to T.Thambal Meitei and gave birth to her sons. Her youngest son Leibakmacha was expired on 1991 at a bike accident. Though illiterate, she knows the value of education and shaped the future of all her sons. Her husband expired when his sons were only 17 years and 15 years old. She had to struggle for the education of her sons. The meagre income she earned from leasing (per day) cycle Rickshaw and also by running the 'mess' for them had helped her in meeting the tuition/education expenses of her sons. Her sweats shaped the career of Shri T.Phulen Meitei.

**Konsam Tomba Singh** was the 3<sup>rd</sup> son of the 12 siblings of Konsam Chaoba Singh and Konsam (O) Tamu Devi of Uripok Sinam, Imphal West. Since his childhood he was very active, dynamic, and responsible and had great love of sports. He received his initial schooling from the then Tombisana High School. After completion of higher secondary school, he completed B.A (Honours) from D.M College in Political Science. Even during his college life he supported his large family in all sphere physically and financially by earning through home tutoring. His love of Football was from his childhood days and eventually started playing for Young Physique Football club. At the age of 24 he married to Konsam (O) Binodini Devi. Later he joined Manipur Police as Sub-

Inspector after receiving his basic training from Punjab Police Academy, Phillaur. As a Police Officer he continued to play for Manipur Police Football team on several events. Even in his professional career as a police officer he was one of the most abled and decorated officer in his time. He was popularly known as OC Tomba during his tenure as he served as Imphal OC on several occasions. He actively dealt with the criminals, insurgency and others cases with prompt actions. On his ability and efficiency he was time and again posted as Imphal OC, who was respected by all and feared by criminals. He thereby solved many cases in which the infamous rape and murder case of Tamphasana Devi. During the peak of Insurgency in the early 90s many insurgency group made life attempt, even planted IED bomb at his residence during anti insurgency campaign. However he survived on every occasion.

He was blessed with 4 children, 3 daughters and 1 son. Later on he was promoted upto the rank of Commandant and commanded Manipur Rifle & IRB battalion.

In an unfortunate event he suffered stroke leading to brain haemorrhage and later diagnosed with Renal Carcinoma, due to which his last breath was on 1<sup>st</sup> May 2015.

In memory of their late parents/father T.Phulen Meitei and Konsam Amita Devi along with their well-wisher decided to open a Sports Academy. Thus, the creation of this TRUST.

- a) "Act" means Indian Trust Act 1882 for the time being and any statutory modifications thereof.
- b) "Sole Founder" mean the founder of the trust "TLT" trust.
- c) "Board" means the board of trustee appointed for the administration of the Trust and the Trustees collectively.
- d) "President/Chairperson" means President/Chairperson of the Trust.
- e) "Secretary" means Secretary of the Trust.
- f) "Treasurer" means Treasurer of the Trust.
- g) Other Designations designated herein *within the Managing Board of Trust* shall hold their respective portfolios and Trustees from time to time.

## 7. OBJECTS FOR WHICH THE TRUST IS ESTABLISHED ARE

Aims & Objective of the trust.

- i) To establish a world class Residential Sports Academy called "TLT Sports Academy" and to produce world class players who can perform at the highest level in the world and bring laurels for the country.
- ii) To spread patriotism through games & sports and in still sense of responsibility in them(players)
- iii) To spread awareness about games & sports and it's positive contribution to the society and hence countering the abuse of drugs and stop the new generation in involving in anti-social activities.
- iv) To help in building a strong nation by bringing it's youths into sports & games through the slogan "Healthy Body, Healthy Mind and Healthy Nation".
- v) To establish, maintain and conduct gymnasium and other physical education and cultural institutions or center of all kinds of useful knowledge for imparting the main instructions in proper and scientific lines in physical, culture and education by means of various kind of athletics, games and sports.
- vi) To impart instruction in the art of self-defence and to inculcate in the minds of members of qualification of leadership, discipline, team spirit, sportsmanship, co-op. service to the social welfare.
- vi) To promote education of children and to spread mass education among the public and to work for the physical and moral welfare of the public.
- vii) To raise fund by receiving donations, subscription etc. from members and public and financial assistance from the Govt. and local bodies.
- xi) To do any such other activities from time to time are essential to achieve the above objects.
- xii) To affiliate with other organisation having similar objects.

## 8. MEMORANDUM OF ASSOCIATION

- i) To affiliate with other organisations having similar objectives.
- ii) To establish a Residential Sports Academy which focuses on, games & sports, alongwith education having the state of art facilities.
- iii) To conduct/sponsor seminar, conference, workshop, competition, awareness programme, counselling, talk, lecture, meeting in furtherance of the games & sports.
- iv) To publish books, journals magazines and reports etc. from time to time in the field of Games and Sports.
- v) To engage in public service activities for realizing the objectives of the trust.
- vi) To accept donation, subscription, contributions, assistance in cash or in kind for the promotion of game and sport from government, semi government, general public and others.
- vii) After the life time of Founder, the consequent consecutive successor shall be the next trustee of the Managing Board in sequence-serial procedure or otherwise as decided within the Board.
- vii) The Secretary and others shall assist Founder in all respects and other respective office bearers/Trustees of the Managing Board shall function their concerned duties/portfolios.
- ix) Further Amendment of this Trust and induction of fresh Trustees is subject to the discretionary power of Founder without any encumbrances whatsoever.

## 9. APPOINTMENT OF THE COMMITTEE:

- a) The Managing Board may from time to time appoint as it thinks a committee for specific purpose with specific assignments on protem basis only and directions under such terms and reference as it think fit and delegate the advisory committee/committee with such powers as it may consider appropriate. Composition of the committee appointed may be under the formulation of the board. Any member(s) within the committee, if found indulging misbehaviour and misconduct, he/she shall be terminated/dismissed/ sacked by the Managing Board.
- b) The Board shall have the right to revoke any of the powers delegated to the committee and dissolve the committee at any time.
- c) The Board shall ordinarily meet as and when required provided that the Managing Trustee approves it in writing or on are requisition of 1/3 trustees/members of the Board may call the Board meeting and not less than seven days' notice shall be given with the prior approval of the President of the Trust.
- d) Quorum, 1/3 trustees/members shall constitute the quorum of any meeting of the Trust.
- e) If at any time appointed for the meeting of the Trust, the quorum is not present, the meeting shall stand adjourned for half an hour. After appointed time and if such adjourned meeting the quorum is not present those members who are present shall be quorum and may transact the business for which the meeting was called. It shall not be necessary to give notice to the members at any such adjourned meeting, This shall also be applicable in case of the Annual Meeting. This annual meeting shall be decided at the discretion of the Sole founder.
- f) In case of equality of votes, the President/Founder of the Trust shall have the right of a casting vote or otherwise as directed by the Sole founder with his team members whom chosen by him from time to time.
- g) Any resolution except such as may be placed before the meeting at the board may be adopted by circulation among all its members/trustees had

h) Expansion of the Board size shall be at the behest of the discretionary power of founder.

k) Correspondence shall be the only concern of the Founder or to any Managing Board Trustee whom authorised by the Founder from time to time

### **11. FUND OF THE TRUST**

a) Donations, Subscriptions, Contribution, Gift assistance from the State and Central Government, NGOs, international and abroad.

b) Interests and income accruing from investment and properties

c) Service charges, maintenance charges, consultation fees and all other income arising and accruing in pursuance of the objective of the Trust.

### **12. POWER, DUTIES AND FUNCTIONS:**

i. The power, duties and rights of the Board of the Trustees in the matters which shall not be expressly provided hereunder shall be regulated in terms of the provisions of the Act.

ii. In addition to the broad functions and duties as expressly provided hereunder the Board may from time to time make such arrangement, draw up such schemes regulate functions and duties of the Trustees.

iii. Every power, authority or discretion herein before or hereinafter conferred upon the Founder/Board shall be exercised or signified either by some instrument in writing to be signed by the trustees or by the resolution of majority of the Trustees who shall be presented and voted, if required, in a meeting of the Board convened under the rules and regulations of the Trusts. At times, president may overrule at his/her will. Sole founder/president is apex decision-making head.

iv. The Board may from time to time invite, seek and mobilize donations, contributions and benefit of the Trust.

v. The president/chairperson of the Managing Board shall chair in all the meetings of the board.

vi. The other Office Bearer Trustees shall function under the guidance and supervision of the sole founding father/president with his board team who are with an absolute power including financial affairs in one's absentia as advice by the sole founding father.

vi. The Secretary shall chair in the meeting in absence of the president.

He/she shall perform duties and functions of the president. He/she shall have absolute power and function in absence of president or on authorisation by the Founder.

vii. The secretary be an office bearer Trustee and shall hold the Office of day to day administration of the Trust under the direction in written or verbal of the president

**13. INCOME, BENEFIT OR ADVANTAGE TOBE APPLIED FOR CHARITABLE PURPOSES**

a) Any income, benefit or advantage will be applied to the public purposes of the Trust.

b) No trustee or members of the Trust or any person associated with a trustee shall participate in or materially influence any decision made by the trustees in respect of any payment to or on behalf of that trustee or associated person of any income, benefit or advantage whatsoever. Any such income paid shall be reasonable and relative to that which would be paid an arm's length transaction (being the open market value).

c) The provision and effect of this clause shall not be removed from this deed and shall be implied into any document replacing this deed of Trust.

#### 14. FINANCIAL ARRANGEMENTS

- a) The financial year of the Trust will be from 1 January to 31 December.
- b) At the first meeting of the Board in each financial year, the Board will decide by resolution the following:
  - i) How they will be received by the Trust;
  - ii) Who will be entitled to produce receipts;
  - iii) What bank accounts will operate for the ensuing year, including the purposes of and access to accounts;
  - iv) Who will be allowed to authorise the production of cheques and the names of cheque signatories; and
  - v) The policy concerning the investment of money by the Trust, including what type of investment will be permitted.
- c) The Treasurer will ensure that true and fair accounts are kept of all money received and expended by the Trust.
- d) The Board may arrange for the accounts of the Trust for that financial year to be audited by an accountant appointed for that purpose.



a) The Common Seal of the Board, following its incorporation, will be kept in the custody and control of the Secretary, or such other officer appointed by the Board.




